CITY OF TORONTO

BY-LAW No. 200-2008

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Toronto Entertainment District Business Improvement Area and to establish a Board of Management for the Toronto Entertainment District Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 125-2008, designated an area generally bounded by Spadina Avenue to the west, Lakeshore Boulevard/Gardiner Expressway to the south, Simcoe Street and Bay Street to the east, and the properties on both sides of Richmond Street West to the north, as a business improvement area under Municipal Code Chapter 19, Business Improvement Areas; and

WHEREAS Toronto and East York Community Council has approved the establishment of a board of management for the Toronto Entertainment District Business Improvement Area, and appointed members to the Toronto Entertainment District Business Improvement Area Board of Management for a term expiring on November 30, 2010, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Toronto Entertainment District Business Improvement Area Board of Management;

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A, Boards of Management is amended by adding the new Toronto Entertainment District Board of Management as set out in Schedule A attached; and
 - B. Schedule A, Maps is amended by adding the attached Maps No. 1 to 4 of the Toronto Entertainment District Business Improvement Area.
2. A Board of Management for the Toronto Entertainment District Business Improvement Area is hereby established.

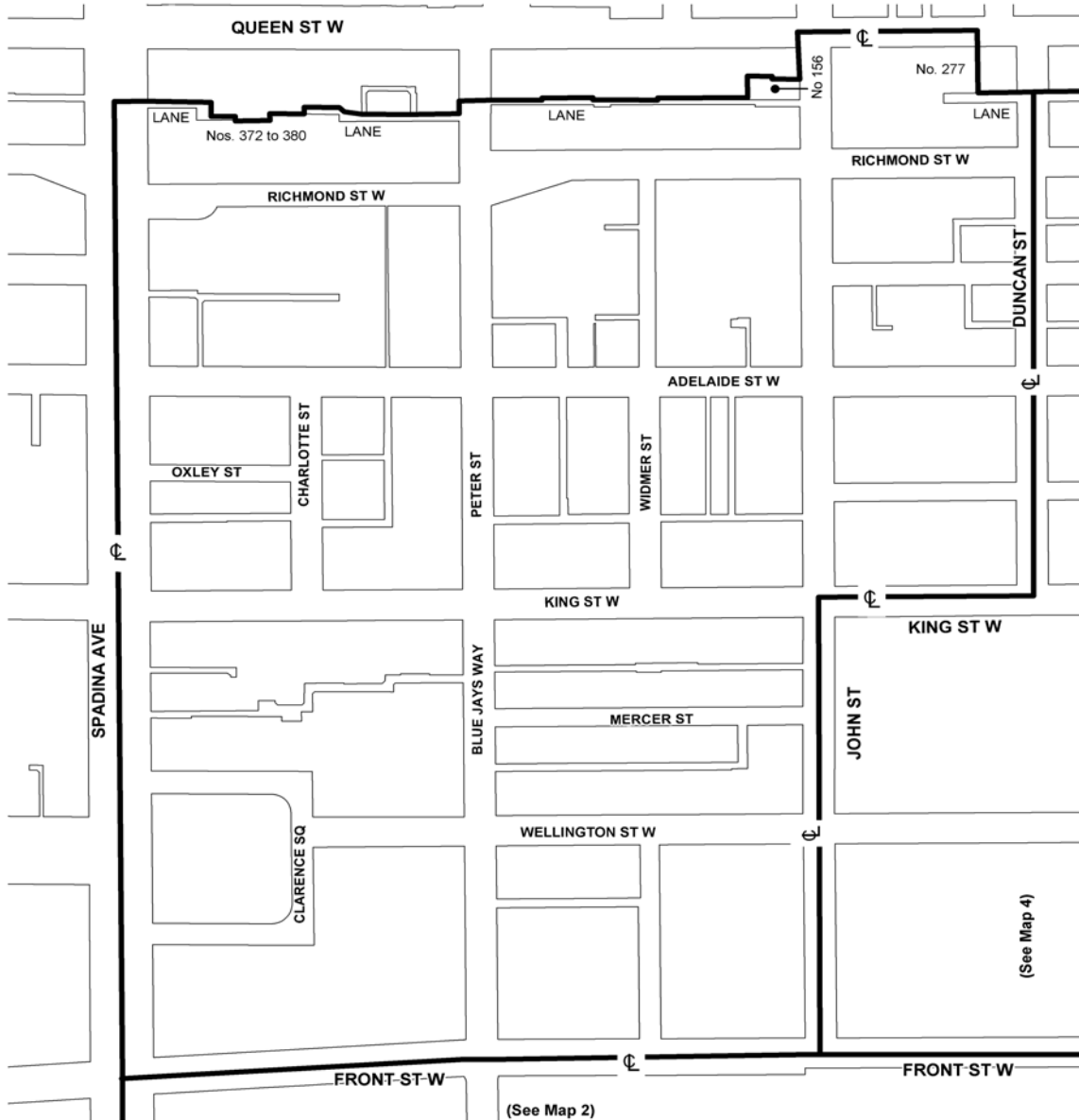

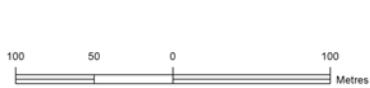

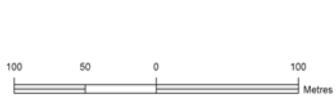
