**CITY OF TORONTO**

**BY-LAW No. 235-2008**

**To amend further Metropolitan Toronto By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Adelaide Street East.**

The Council of the City of Toronto HEREBY ENACTS as follows:

- Schedule IX (No Stopping) of Metropolitan Toronto By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

- Schedule X (Parking for Restricted Periods) of Metropolitan Toronto By-law No. 32-92, as amended, is hereby further amended by striking out the following words and figures where they occur opposite each other in Columns 1, 2, 3, 4 and 5 of the said Schedule:

Adelaide Street East (M.T. 36)	North	George Street and Sherbourne Street	8:00 a.m. to 4:00 p.m. Monday to Friday 8:00 a.m. to 6:00 p.m. Saturday, except Public Holidays	1 hour
