BY-LAW No. 263-2008

To provide for the exception to certain disabled permit parking exemptions regarding Avenue Road/University Avenue, Bayview Avenue, Bloor Street/Danforth Avenue, Eglinton Avenue, Finch Avenue West, Lawrence Avenue East, McCowan Road, The Queensway and Yonge Street, in the event of a strike or lockout affecting service by the Toronto Transit Commission.

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** Municipal Code Chapter 903, Parking for Persons with Disabilities is amended by adding the following as § 903-6B(7):
 - (7) On any of the streets listed in the chart below in Column 1, on both sides of the street, on the portion of the street set out in Column 3 at the times and dates set out in Column 4.

- 2. Despite any by-law or Municipal Code provision to the contrary, no person displaying a valid disabled parking permit shall be exempt from prohibitions on parking a vehicle on any of the streets listed in Column 1 of the chart set out in section 1 of this by-law, on both sides of the street, on the portion of the street set out in Column 3 of the chart at the times and dates set out in Column 4 of the chart.
- **3.** This By-law shall be effective commencing from 12:01 a.m. on the first day of a Toronto Transit Commission strike or lockout affecting all or a portion of public transit service from and after April 1, 2008, and shall cease to be in effect on the earlier of:
 - (i) 12:01 a.m. of the first day following the return to normal transit operations of the Toronto Transit Commission; and
 - (ii) June 25, 2008.
- **4.** The amendments made to Chapter 903 in section 1 of this by-law shall be repealed immediately prior to the date and time where the by-law ceases to be in effect under section 3.
