BY-LAW No. 279-2008

To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding Vanley Crescent.

The North York Community Council HEREBY ENACTS as follows:

1. Schedule "X" (Parking for Restricted Times) of By-law No. 31001, of the former City of North York, is amended by deleting from Columns 1, 2, 3, 4 and 5 the following:

2. Schedule "X" (Parking for Restricted Times) of By-law No. 31001, of the former City of North York, is amended by adding to Columns 1, 2, 3, 4 and 5 the following:
