BY-LAW No. 287-2008

To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads”, regarding Briar Hill Avenue.

The North York Community Council HEREBY ENACTS as follows:

1. That Schedule VIII (No Parking) of former City of York By-law No. 2958-84, as amended, be further amended by deleting from Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Briar Hill Avenue	North	A point 30 metres east of Dufferin Street and a point 36 metres east thereof	8:00 a.m. to 6:00 p.m., Monday to Friday, except public holidays

2. That Schedule IX (No Stopping) of former City of York By-law No. 2958-84, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Briar Hill Avenue	South	Dufferin Street and a point 145 metres east	8:00 a.m. to 9:30 a.m., 2:30 p.m. to 4:00 p.m., Monday to Friday

3. That Schedule X (Parking for Restricted Periods) of former City of York By-law No. 2958-84, as amended, be further amended by inserting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>	<u>Column 5</u> <u>Maximum</u> <u>Period</u> <u>Permitted</u>
Briar Hill Avenue	North	A point 30 metres east of Dufferin Street and a point 66 metres east of Dufferin Street	8:00 a.m. to 4:00 p.m., Monday to Friday	15 Min.
