BY-LAW No. 296-2008

To amend further By-law No. 23503 of the former City of Scarborough, respecting the regulation of traffic on Hedge End Road, Crescentwood Road, Glaive Road, Wye Valley Road, Great West Drive, Cass Avenue and various other streets.

The Scarborough Community Council HEREBY ENACTS as follows:
