## BY-LAW No. 303-2008

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Ashdale Avenue, Barton Avenue, Canning Avenue, Clinton Street, Greenwood Avenue, Markham Street, Munro Street, Rankin Crescent and Rhodes Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

- **1.** Municipal Code Chapter 903, Parking for Persons with Disabilities, of the City of Toronto is amended as follows:
