BY-LAW No. 306-2008

To amend further Metropolitan Toronto By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Avenue Road, Farnham Avenue, Foxbar Road, Jackes Avenue and Yonge Street.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Schedule XV (Prohibited Turns) of Metropolitan Toronto By-law No. 32-92, as amended, is hereby further amended by striking out the words and figures:
