BY-LAW No. 419-2008

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Craydon Avenue, Criscoe Street, Chudleigh Road, Harvie Avenue, Hope Street, Osler Street and Pacific Avenue.

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, of the City of Toronto is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

| (From Column 1) | (From Column 2) | (From Column 3) | (From Column 4) |
|-----------------|-----------------|---|-----------------|
| Harvie Avenue | East | A point 26.5 metres south of Hope Street and a point 5.5 metres further south | Anytime |
| Harvie Avenue | West | A point 31.5 metres south of Hope Street and a point 5.5 metres further south | Anytime |
| Hope Street | North | A point 32.5 metres east of Harvie Avenue and a point 5.5 metres further east | Anytime |
| Hope Street | South | A point 28.3 metres west of Boon Avenue and a point 5.5 metres further west | Anytime |
| Pacific Avenue | Both | A point 72.5 metres south of Oakmount Road and a point 5.5 metres further south | Anytime |

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

| (In Column 1) | (In Column 2) | (In Column 3) | (In Column 4) |
|-------------------|------------------|---|------------------|
| Craydon Avenue | South | A point 167 metres east of Weston Road and a point 5.5 metres further east | Anytime |
| Criscoe Street | East | A point 85 metres north of Henrietta Street and a point 5.5 metres further north | Anytime |
| Chudleigh Road | North | A point 12 metres east of Harvie Avenue and a point 5.5 metres further east | Anytime |
| Osler Street | East | A point 44.5 metres south of Davenport Road and a point 5.5 metres further south | Anytime |
