BY-LAW No. 458-2008

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Atlas Avenue, Marion Street, Middleton Street, Mountjoy Avenue, Ridley Gardens, Shank Street and Wildwood Crescent.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the City of Toronto is amended as follows:
 - A. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders), in § 400-91, the following in alphabetical order by street name:

Marion Street	South	A point 46.5 metres west of Sorauren Avenue and a point 5.5 metres further west thereof	Anytime
Mountjoy Avenue	South	A point 42 metres east of Gillard Avenue and a point 5.5 metres further east thereof	Anytime
Ridley Gardens	West	A point 36 metres north of Garden Avenue and a point 5.5 metres further north	Anytime
Wildwood Crescent	North	A point 132 metres east of Kingsmount Park Road and a point 5.5 metres further east	Anytime
Wildwood Crescent	North	A point 90 metres west of Ladykirk Avenue and a point 5.5 metres further west	Anytime

B. By inserting in Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders), in § 400-91, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Atlas Avenue	East	A point 30.5 metres north of Earlsdale Avenue and a point 5.5 metres further north	Anytime
Middleton Street	South	A point 20.5 metres west of Sheridan Avenue and a point 5.5 metres further west	Anytime
Shank Street	South	A point 9 metres west of Massey Street and a point 5.5 metres further west	Anytime
Wildwood Crescent	South	A point 132 metres east of Kingsmount Park Road and a point 5.5 metres further east	Anytime
