BY-LAW No. 510-2008

To assume municipal services located in and on Gristone Crescent, Knowles Drive, Loggerhead Grove, Osprey Court, Point Rouge Trail (north side of Knowles Drive), Point Rouge Trail (south side of Knowles Drive), Siskin Terrace, Warbler Circle (eastern portion) and Warbler Circle (western portion), being the streets on Plan 66M-2395.

WHEREAS the City has entered into a Subdivision Agreement with Trans-Gate Inc. to provide for the public highway and municipal services on Plan 66M-2395 and all affected City Divisions have no objection to the City's intention to assume the municipal services installed pursuant to the Subdivision Agreement;

The Council of the City of Toronto HEREBY ENACTS as follows:
