BY-LAW No. 540-2008

To amend further By-law No. 92-93, a by-law “To regulate traffic on roads in the Borough of East York”, being a by-law of the former Borough of East York, respecting Parkhurst Boulevard.

The North York Community Council HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by striking out the following words and figures where they appear opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(From Column 1 Road)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and Days)
Parkhurst Boulevard	North	Laird Drive and Sutherland Drive	8:00 a.m. to 10:00 a.m. and 3:00 p.m. to 5:00 p.m. Monday to Friday

2. Schedule VIII (No Parking) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting in the Columns 1, 2, 3 and 4 of the said Schedule, between the words “Douglas Crescent” and “Dunkirk Road” where they appear in Column 1 of the said Schedule, the following:

(In Column 1 Road)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Time and Days)
Parkhurst Boulevard	North	Laird Drive and a point 42 metres west	Anytime
Parkhurst Boulevard	North	The east limit of Sutherland Drive and the east limit of Randolph Road	8:00 a.m. to 10:00 a.m. and 3:00 p.m. to 5:00 p.m., Monday to Friday

3. Schedule X (Parking for Restricted Periods) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting in the Columns 1, 2, 3, 4 and 5 of the said Schedule, between the words "Parkhurst Boulevard" and Plains Road" where they appear in Column 1 of the said Schedule, the following:

(In Column 1 Road)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and Days)	(In Column 5 Max. Period Permitted)
Parkhurst Boulevard	North	The east limit of Randolph Road and a point 42 metres west of Laird Drive	8:00 a.m. to 5:00 p.m. Monday to Friday	15 mins.
