**CITY OF TORONTO**

**BY-LAW No. 550-2008**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Barnaby Place, Brownlow Avenue, Mallory Gardens and Ulster Street.**

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:
