BY-LAW No. 555-2008

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Austin Terrace, Browning Avenue and Chisholm Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Austin Terrace	South	A point 38.1 metres east of Austin Crescent and a point 45.7 metres further east	Each Thursday, from April 1 to November 30, inclusive

Chisholm Avenue	East	Danforth Avenue and the north City limit	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
