**BY-LAW No. 669-2008**

**To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding Whitfield Avenue and Emily Avenue.**

The Etobicoke York Community Council HEREBY ENACTS as follows:
