## CITY OF TORONTO

### BY-LAW No. 712-2008

#### To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Cowan Avenue, Fort Rouille Street, Gladstone Avenue, Spencer Avenue and Strachan Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule VIII (Prohibited Turns) in § 400-61, the following in alphabetical order by street name:

Strachan Avenue, between Fleet Street and Lake Shore Boulevard West	Northbound and Southbound	U-turns	Anytime, from and including Fri., Aug. 15, 2008 to and including Mon., Sept. 1, 2008

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Cowan Avenue	West	Springhurst Avenue and the south end of Cowan Avenue	Anytime, from and including Fri., Aug. 15, 2008 to and including Mon., Sept. 1, 2008
Fort Rouille Street	East	The south end of Fort Rouille Street and a point 30.5 metres south of Springhurst Avenue	Anytime, from and including Fri., Aug. 15, 2008 to and including Mon., Sept. 1, 2008
Fort Rouille Street	West	The south end of Fort Rouille Street and a point 36.5 metres south of Springhurst Avenue	Anytime, from and including Fri., Aug. 15, 2008 to and including Mon., Sept. 1, 2008
