BY-LAW No. 804-2008

To amend further By-law No. 23503 of the former City of Scarborough, respecting the regulation of traffic on Pharmacy Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by striking out the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:

Pharmacy Avenue	Both	A point 45 metres south of Denton Avenue	A point 30 metres south of Alvinston Road	Anytime
