**CITY OF TORONTO**

**BY-LAW No. 819-2008**

**To amend further Metropolitan Toronto By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding William R. Allen Road, Highway 401 Off-Ramp, Yorkdale Road and Yorkdale Mall Access.**

The Council of City of Toronto HEREBY ENACTS as follows:

- Schedule VI (Prohibited Pedestrian Crossings) of Metropolitan Toronto By-law No. 32-92, as amended, is hereby further amended by inserting the following words and figures opposite each other in Columns 1 and 2 of the said Schedule:

Yorkdale Road and the William R. Allen Road/Highway 401 Off-ramp/Yorkdale Mall Access	Between the north curb line of William R. Allen Road/Highway 401 Off-ramp/Yorkdale Mall access and a point 30.5 metres north
Yorkdale Road and the William R. Allen Road/Highway 401 Off-ramp/Yorkdale Mall Access	Between the south curb line of William R. Allen Road/Highway 401 Off-ramp/Yorkdale Mall access and a point 30.5 metres south
