**CITY OF TORONTO**

**BY-LAW No. 854-2008**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting Bremner Boulevard, Lower Simcoe Street and Simcoe Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

Lower Simcoe Street	East	Lake Shore Boulevard West and Bremner Boulevard	Anytime
Lower Simcoe Street	West	Bremner Boulevard and a point 31.5 metres south	Anytime
