**CITY OF TORONTO**

**BY-LAW No. 972-2008**

**To dedicate certain land on the south side of Sheppard Avenue West, west of  
Wilson Heights Boulevard, for public highway purposes to form part of the public highway  
Sheppard Avenue West.**
