BY-LAW No. 1059-2008

To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding Applebaum Terrace, Assiniboine Road, Boake Street, Boot Terrace, Hackett Avenue, Haynes Avenue, Jack Evelyn Wiggins Drive, Leitch Avenue, Saywell Avenue, Sheffer Terrace and Troyer Avenue.

The North York Community Council HEREBY ENACTS as follows:
