BY-LAW No. 1103-2008

To amend City of Toronto Municipal Code Chapter 925, Permit Parking, regarding Browning Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 925, Permit Parking, is amended as follows:

A. By deleting from Schedule A (Permit Parking), the following in alphabetical order by street name:

Browning Avenue	Even	From Jackman Avenue to a point 54.7 metres east of Carlaw Avenue	All times, except no parking from 8:00 a.m. on the 16th day of each month to 8:00 a.m. on the first day of the next month, from Apr. 1 to Dec. 1, inclusive	12:01 a.m. to 7:00 a.m.
Browning Avenue	Odd	From Jackman Avenue to a point 54.7 metres east of Carlaw Avenue	All times, except no parking from 8:00 a.m. on the first day of each month to 8:00 a.m. on the 16th day of each month, from Apr. 1 to Dec. 1, inclusive, and no parking anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive	12:01 a.m. to 7:00 a.m.

B. By inserting in Schedule A (Permit Parking), the following in alphabetical order by street name:

Browning Avenue	Even	From Jackman Avenue to a point 54.7 metres east of Carlaw Avenue	All times, except no parking from the 16th day of each month to the first day of the next month, from Apr. 1 to Dec. 1, inclusive	12:01 a.m. to 7:00 a.m.
Browning Avenue	Odd	From Jackman Avenue to a point 54.7 metres east of Carlaw Avenue	All times, except no parking from 10:00 a.m. on the first day of each month to 10:00 a.m. on the 16th day of each month, from Apr. 1 to Dec. 1, inclusive, and no parking anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive	12:01 a.m. to 7:00 a.m.
