CITY OF TORONTO

BY-LAW No. 1144-2008

To amend City of Toronto Municipal Code Chapter 103, Heritage, Article III, Preservation Board; Community Preservation Panels, to implement the City Planning Division's policy and processes governing the Toronto Preservation Board and the Community Preservation Panels and to make technical amendments.

WHEREAS the City's Policy for Citizen Nomination to City Agencies, Boards, Commissions and Corporations does not apply to the Toronto Preservation Board or the Community Preservation Panels; and

WHEREAS Council has approved a policy and process for citizen nominations and membership on the Toronto Preservation Board and the Community Preservation Panels; and

WHEREAS certain technical amendments are required to bring policies and processes in line with current structure and practice;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. Municipal Code Chapter 103, Heritage, Article III, Preservation Board; Community Preservation Panels is amended by:
- A. Deleting the definition of General Manager in § 103-16.
- B. Inserting the following definition in § 103-16 in alphabetical sequence:

CHIEF PLANNER — The City's Chief Planner and Executive Director, City Planning Division.

- C. Deleting all references to the General Manager and substituting the Chief Planner.
- D. Inserting the following definition in § 103-16 in alphabetical sequence:

INVENTORY OF HERITAGE PROPERTIES — A list which identifies the City's built cultural heritage.

- E. Deleting the definition of Natural Heritage in § 103-16 and the words "natural heritage" in § 103-18C(4).
- F. By adding the following as § 103-17B(5):

Despite § 103-17B(3) a member who is absent for 3 consecutive meetings without reasonable excuse may be subject to removal from office.

- G. Deleting subsections § 103-17C(1), (2), (5), (6) and (7) and substituting the following:
 - (1) Designation of individual heritage properties and heritage conservation districts and inclusion of properties on the Inventory of Heritage Properties;
 - (2) Applications to alter, demolish or remove properties included on the Inventory of Heritage Properties;
 - (5) The Inventory of Heritage Properties;
 - (6) The criteria and process for inclusion of properties on the Inventory of Heritage Properties;
 - (7) Cultural heritage landscape issues respecting properties on the Inventory of Heritage Properties.
- H. Deleting subsections § 103-18(1) and (3) and substituting the following:
 - (1) Recommend properties within the local community which should be considered by the Board for inclusion on the Inventory of Heritage Properties;
 - (3) Research into properties being proposed for inclusion on the Inventory of Heritage Properties, public programs and other preservation-related issues;
- I. Deleting the words "List and" in § 103-18C(2) and capitalizing the word "monitor".
- J. Deleting all references to the Planning and Transportation Committee and substituting the Planning and Growth Management Committee.
- K. Deleting the words "local architectural conservation advisory committee in § 103-17A and substituting the words "municipal heritage committee".
- L. Deleting the words " for a term consistent with the City's Policy on Citizen Appointments to City of Toronto Agencies, Boards and Commissions and External Special-Purpose Bodies" in § 103-17F and substituting the words " for a maximum of two consecutive terms".
- M. Deleting the number 11 in § 103-18B(1) and substituting the number 15.
- N. Adding the following as subsection § 103-18B(3):
 - (3) Panel members shall possess special interests or knowledge that will assist the Panel in fulfilling its responsibilities.
- O. Adding the following as subsection § 103-18B(11):
 - (11) Report to the Toronto Preservation Board.

- P. Deleting § 103-18D.
- Q. Re-numbering section § 103-18E as § 103-18D and deleting the words "for a term consistent with the City's Policy on Citizen Appointments to City of Toronto Agencies, Boards and Commissions and External Special-Purpose Bodies and substituting the words "for a maximum of two consecutive terms".
- R. Adding the following as § 103-18E:

Despite § 103-18D a citizen member of a Panel who served during the 2004-2006 term may serve for more than two consecutive terms.

S. By adding the following as § 103-18F(7):

Despite § 103-18F(5) a member who is absent for 3 consecutive meetings without reasonable excuse may be subject to removal from office.
