BY-LAW No. 1192-2008

To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads”, regarding Northcliffe Boulevard.

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. That Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, be further amended by deleting from Columns 1, 2, 3 and 4 of the said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Northcliffe Boulevard	West	A point 60.3 metres north of St. Clair Avenue West and a point 21.4 metres north thereof	Anytime

2. That Schedule VIII (No Parking) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Northcliffe Boulevard	West	A point approximately 61.2 metres north of St. Clair Avenue West and a point 82.7 metres north of St. Clair Avenue West	9:01 a.m. to 11:29 a.m., 1:01 p.m. to 3:29 p.m., and 6:01 p.m. of one day to 7:29 a.m. of the next following day, Mon. to Fri.; Anytime Sat. and Sun.

3. That Schedule X (Parking for Restricted Periods) of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>	<u>Column 4 Prohibited Period Permitted</u>
Northcliffe Boulevard	West	A point approximately 61.2 metres north of St. Clair Avenue West and a point 82.7 metres north of St. Clair Avenue West	9:00 a.m. to 11:30 a.m., 1:00 p.m. to 3:30 p.m., and 6:00 p.m. of one day to 7:30 a.m. of the next following day, Mon. to Fri.	10 mins.
