## **CITY OF TORONTO**

### **BY-LAW No. 1199-2008**

**To rename part of the public highway Old Leslie Street as “Esther Shiner Boulevard” and to dedicate land for public highway purposes to be named “Esther Shiner Boulevard”.**

The North York Community Council HEREBY ENACTS as follows:

1. Part of the public highway Old Leslie Street shown on Attachment 1 to this By-law, being Map 52N-23 dated June 12, 2008, and described by W. Kowalenko, O.L.S., City Surveyor, as follows, namely:

In the City of Toronto (former City of North York) and Province of Ontario, in the Land Titles Division of the Toronto Registry Office (No. 66) being composed of:

**FIRSTLY:**

Part of PIN 10090-0403 (LT)

Part of Lot 15, Concession 2 East of Yonge Street Twp of York, designated as PARTS 8, 9, 12 and 13 on Plan 66R-23943

**SECONDLY:**

Part of PIN 10090-0404 (LT)

Part of Lot 15, Concession 2 East of Yonge Street Twp of York, designated as PARTS 15 and 16 on Plan 66R-23943

**THIRDLY:**

Part of PIN 10090-0410 (LT)

Part of Lot 15, Concession 2 East of Yonge Street Twp of York, designated as PARTS 18, 19, 20 and 21 on Plan 66R-23943

is renamed as “Esther Shiner Boulevard”.

FOURTHLY:

Part of PIN 10090-0403 (LT)  
Part of Lot 15, Concession 2 East of Yonge Street Twp of York, designated as PART 14 on Plan 66R-23943

is dedicated for public highway purposes to be named "Esther Shiner Boulevard".

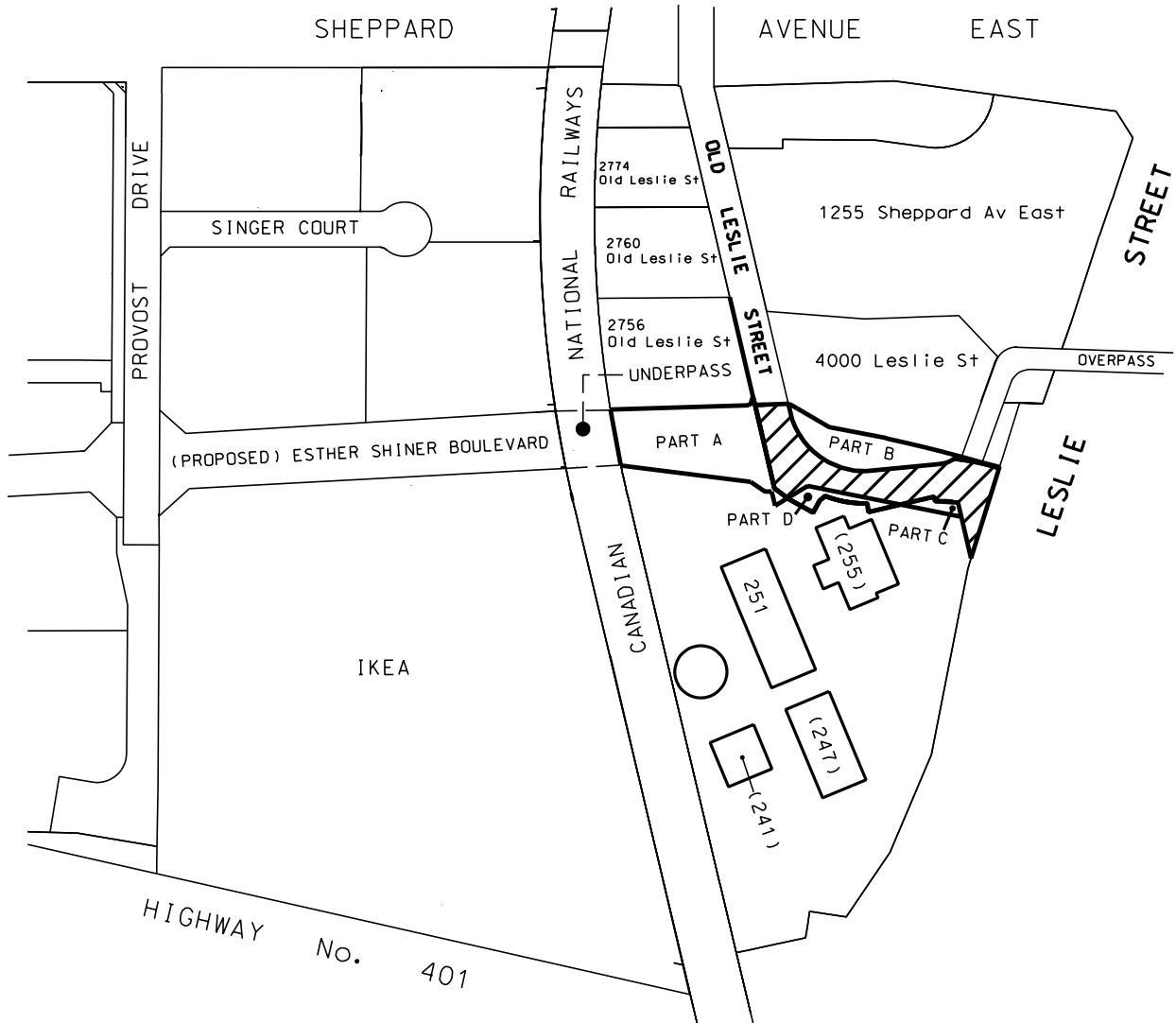
