BY-LAW No. 1228-2008

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Ellerbeck Street, Hawarden Crescent, St. Thomas Street, Spadina Road, Tilson Road and Waverley Road.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule IV (Stop Intersections) in § 400-57, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)
Tilson Road and Harwood Road	Tilson Road (westbound)

B. By inserting in Schedule IX (Compulsory Turns) in § 400-62, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)
Spadina Road	Hawarden Crescent, west of Spadina Road	Hawarden Crescent, east of Spadina Road, from 8:00 a.m. to 9:15 a.m., 11:30 a.m. to 1:15 p.m. and 3:00 p.m. to 4:00 p.m., Mon. to Fri. from Sept. 1 of one year to June 30 of the next following year, inclusive

C. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Ellerbeck Street	West	Danforth Avenue and the first lane north of Danforth Avenue	Anytime
St. Thomas Street	West	Entire length	Anytime

D. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
St. Thomas Street	West	Sultan Street and Bloor Street West	Anytime
Waverley Road	West	A point 184 metres south of Queen Street East and a point 12.3 metres further south	Anytime

E. By inserting in Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
St. Thomas Street	West	Charles Street West and Sultan Street	Anytime
