BY-LAW No. 1269-2008

To amend City of Toronto Municipal Code Chapter 441, Fees and Charges.

WHEREAS pursuant to sections 259, 7 and 8 of the *City of Toronto Act, 2006*, the City may pass by-laws imposing fees or charges on persons for services or activities provided or done by or on behalf of it and for the use of its property including property under its control; and

WHEREAS City Council has approved various bicycle station user fees; and

WHEREAS it is necessary to amend City of Toronto Municipal Code Chapter 441, Fees and Charges, to include the new bicycle station fees; and

WHEREAS City Council has approved various fees related to the rental of bicycle lockers and these bicycle locker rental fees were previously added to Appendix C, Schedule 16, Planning, of Municipal Code Chapter 441, Fees and Charges; and

WHEREAS it is more appropriate and desirable for these bicycle locker rental fees to be contained in Appendix C, Schedule 2, Transportation, of Municipal Code Chapter 441, Fees and Charges, together with the bicycle station fees; and

WHEREAS the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code to correct technical errors;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Appendix C, All Other Fees, Schedule 16, Planning, of the City of Toronto Municipal Code Chapter 441, Fees and Charges, is amended by deleting the following, in numerical order by row number:
