BY-LAW No. 1289-2008

To amend further Metropolitan Toronto By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Richmond Street East and Richmond Street West.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan Toronto By-law No. 32-92, as amended, is hereby further amended by striking out the words and figures:
