BY-LAW No. 17-2010

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Kennedy Avenue.

The Etobicoke York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule VIII (Prohibited Turns) in § 400-61, the following in alphabetical order by street name:
