**CITY OF TORONTO**

**BY-LAW No. 25-2010**

**To amend By-law No. 31001 of the former City of North York, respecting the regulation of traffic on North York roads, regarding Jack Evelyn Wiggins Drive and Elia Lane.**

The North York Community Council HEREBY ENACTS as follows:
