BY-LAW No. 67-2010

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Abbott Avenue, Boulton Avenue, Brad Street, Clinton Street, Constance Street, Craven Road, Devon Road, Emerson Avenue, Euclid Avenue, Geoffrey Street, Glebeholme Boulevard, Grenadier Road and Yarmouth Road.

The Toronto and East York Community Council HEREBY ENACTS as follows:

- 1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A.** By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Emerson Avenue	West	A point 92.7 metres north of Bloor Street West and a point 5.8 metres further north	Anytime from the 16th day to the last day of each month, Apr. 1 to Nov. 30, inclusive
Geoffrey Street	North	A point 115 metres west of Sorauren Avenue and a point 6.5 metres further west	Anytime
Glebeholme Boulevard	South	A point 36 metres west of Woodmount Avenue and a point 5.5 metres further west	Anytime
