CITY OF TORONTO

BY-LAW No. 73-2010

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Annex-Dupont Business Improvement Area and to establish a Board of Management for the Annex-Dupont Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 1186-2009, designated an area along Dupont Street from Davenport Road to just west of Walmer Road, as a business improvement area under Municipal Code Chapter 19, Business Improvement Areas; and

WHEREAS Toronto and East York Community Council has established a board of management for the Annex-Dupont Business Improvement Area, and appointed members to the Annex-Dupont Business Improvement Area Board of Management for a term expiring on November 30, 2010, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Annex-Dupont Business Improvement Area Board of Management;

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A, Boards of Management is amended by adding the new Annex-Dupont Board of Management as set out in Schedule A attached; and
 - B. Schedule A, Maps is amended by adding the attached map of the Annex-Dupont Business Improvement Area.
2. A Board of Management for the Annex-Dupont Business Improvement Area is hereby established.

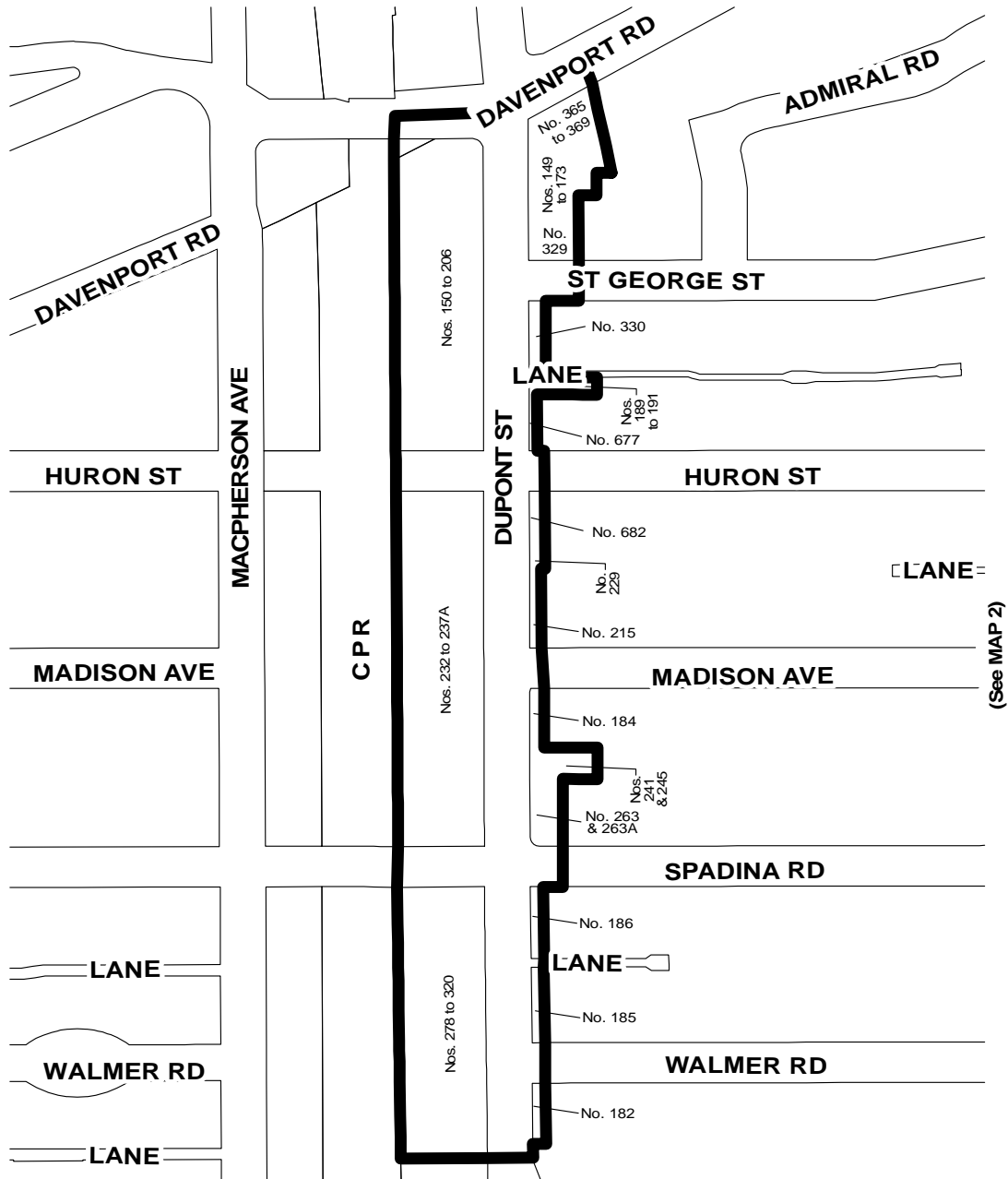
