BY-LAW No. 174-2010

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting College Street, Dixon Avenue, Hiawatha Road, Major Street, Perth Avenue, Roseheath Avenue and Westmoreland Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, of the City of Toronto is amended as follows:

A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

College Street (north branch)	North	A point 36 metres east of St. Helen's Avenue and a point 5.5 metres further east	Anytime

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

Dixon Avenue	South	A point 9 metres west of Woodbine Avenue and a point 5.5 metres further west	Anytime
Hiawatha Road	East	A point 61 metres south of Gerrard Street East and a point 5.5 metres further south	Anytime
Major Street	East	A point 148 metres south of Ulster Street and a point 5.5 metres further south	Anytime
Perth Avenue	East	A point 140.9 metres north of Bloor Street West and a point 5.5 metres further north	Anytime

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Roseheath Avenue	West	A point 23 metres north of Hanson Street and a point 5.5 metres further north	Anytime
Westmoreland Avenue	East	A point 71.5 metres south of Dupont Street and a point 5.5 metres further south	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive; and from the 1st day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive
Westmoreland Avenue	West	A point 69.5 metres south of Dupont Street and a point 5.5 metres further south	Anytime from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
