CITY OF TORONTO

BY-LAW No. 195-2010

To amend City of Toronto Municipal Code Chapter 441, Fees and Charges, and to amend City of Toronto Municipal Code Chapter 363, Construction and Demolition, with respect to certain fee schedule amendments.

WHEREAS subsection 8(1) of the *City of Toronto Act, 2006* provides the City with broad authority to provide any service or thing the City considers necessary or desirable for the public; and

WHEREAS City Council has the authority to pass by-laws respecting matters related to Structures, including fences and signs under subsection 8(2) of the *City of Toronto Act*, 2006; and

WHEREAS section 259 of the *City of Toronto Act, 2006* provides that the City may pass by-laws imposing fees and charges on persons for services or activities provided or done by or on behalf of it; and

WHEREAS section 7 of the *Building Code Act, 1992*, authorizes a municipal council to pass by-laws concerning the issuance of permits and related matters; and

WHEREAS it is necessary to provide that Toronto Building has the ability to recover the cost of administering services respecting the erection of signs; and

WHEREAS the City provides regulation of the erection and display of signs to the citizens of Toronto as a necessary and desirable service; and

WHEREAS it is necessary to amend Chapter 441, Fees and Charges, of the Toronto Municipal Code to include the fees related to the regulation of signs; and

WHEREAS it is necessary to amend Chapter 363, Building Construction and Demolition, of the Toronto Municipal Code to include the fees related to the regulation of the erection of signs; and

WHEREAS notice of the intention to enact this by-law has been provided in accordance with the *City of Toronto Act, 2006* and its regulations;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Chapter 441, Fees and Charges, of the Municipal Code of the City of Toronto is amended by deleting Appendix C - Schedule 8, Toronto Building, of City of Toronto Municipal Code Chapter 441, Fees and Charges, in its entirety and replacing it with Schedule "1" to this By-law.

- 2. Chapter 363, Construction and Demolition, of The City of Toronto Municipal Code, is amended by adding a new building classification "Sign structure" in the left hand column and a corresponding fee in the right hand column of "\$55.00 per installation" to Part E. Stand Alone and Miscellaneous Work of Schedule A, to Chapter 363, Article I, Classes of Permits and Permit Fees.
- **3.** This by-law comes into force on the 6th day of April, 2010.
