BY-LAW No. 235-2010

To amend further Metropolitan Toronto By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Bloor Street East, Bloor Street West, Charles Street East, Jarvis Street, Mount Pleasant Road and Ted Rogers Way.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VI (Prohibited Pedestrian Crossings) of Metropolitan Toronto By-law No. 32-92, as amended, is hereby further amended by striking out the words and figures:

Jarvis Street (M.T. 31)	Between the north curb line of Charles Street East and a point 30.5 metres south of the south curb line of Charles Street East
