BY-LAW No. 354-2010

To amend By-law No. 196-2010, "To adopt a new City of Toronto Municipal Code Chapter 694, Signs, General", to make technical amendments and correct minor technical errors.

WHEREAS on November 30, December 1, 2, 4 and 7, 2009, City Council adopted, as amended, Public Works and Infrastructure Committee Item 33.10, which contained provisions concerning Harmonized Sign Regulations for the City of Toronto; and

WHEREAS on January 26 and 27, 2010, City Council adopted, as amended, Public Works and Infrastructure Committee Item 34.1, which contained amendments to the Harmonized Sign Regulations for the City of Toronto; and

WHEREAS at its meeting of February 22 and 23, 2010, City Council adopted By-law No. 196-2010, which by-law enacted Chapter 694, Signs, General, to the City of Toronto's Municipal Code; and

WHEREAS Chapter 694, Signs, General, requires minor technical amendments to accurately reflect what Council adopted; and

WHEREAS under § 169-26 of Municipal Code Chapter 169, Officials, City, the City Solicitor, in consultation with the City Clerk, may submit bills directly to Council to make technical amendments to the Municipal Code and other by-laws to correct technical errors;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Chapter 694, Signs, General, as set out in By-law No. 196-2010, "To adopt a new City of Toronto Municipal Code Chapter 694, Signs, General", is amended as follows:
 - (A) Subsection 694-26G(1) is hereby amended by deleting the phrase "City Hall Nathan Philips Square Special Sign District" and substituting it with the phrase "University Avenue Special Sign District";
 - (B) Subsection 694-26H is amended by deleting the phrase "on the SSD-GG map at Schedule A" wherever it appears and substituting the the phrase "within the GG-SSD as set out in Schedule A" throughout;
 - (C) Subsection 694-26I is amended by deleting the phrase "on the SSD-GG map at Schedule A" wherever it appears and substituting it with the phrase, "within the GG-SSD as set out in Schedule A" throughout;

- (D) Subsection 694-22C is hereby amended by deleting the phrase "on a listed heritage building or a designated heritage building" and substituting it with the phrase "in a heritage conservation district, or on a listed heritage building or a designated heritage building";
- (E) Subsection 694-24A(11) is hereby amended by deleting the phrase "Highway from Highway 401 to the City of Toronto and Durham boundary" and substituting it with the phrase "Highway 2 from Highway 401 to the City of Toronto and Durham boundary"; and
- (F) Subsection 694-24A(20) is hereby amended by deleting the phrase "from westerly limit of Coxwell Avenue to the easterly limit of Victoria Park Avenue" and substituting it with the phrase "from the westerly limit of Coxwell Avenue to the easterly limit of Victoria Park Avenue".

2. This by-law comes into force on the 6th day of April, 2010.
