BY-LAW No. 500-2010

To amend the former City of Toronto Municipal Code Chapter 194, Footpaths, Bicycle Lanes and Pedestrian Ways, respecting bicycle lanes on Rathburn Road.

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** Chapter 194, Footpaths, Bicycle Lanes and Pedestrian Ways, of the former City of Toronto Municipal Code, is amended as follows:
- A. By adding in alphabetical order to the list of bicycle lanes in § 194-6A the following:

Rathburn Road	South, adjacent to right-turn lane	Edenwood Drive and a point 50 metres west

Rathburn Road	South, adjacent to curb	Edenwood Drive and a point 49.9 metres west of Haliburton Avenue
Rathburn Road	South, adjacent to right-turn lane	Haliburton Avenue and a point 49.9 metres west

Rathburn Road	North, adjacent to right-turn lane	Lloyd Manor Road and a point 50 metres east
