BY-LAW No. 571-2010

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Albany Avenue, Armstrong Avenue, Craven Road, Fermanagh Avenue, Lindsey Avenue, Oriole Gardens, Paton Road, Spruce Street and Winchester Street.

The Toronto and East York Community Council HEREBY ENACTS as follows:

- **1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
- A. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:
