## **CITY OF TORONTO**

### **BY-LAW No. 581-2010**

#### **To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Kensington Market Business Improvement Area and to establish a Board of Management for the Kensington Market Business Improvement Area.**

WHEREAS Council, by the adoption of By-law No. 1187-2009, designated an area surrounded by Bathurst Street, Wales Avenue and the properties on Bellevue Avenue just north of Nassau Street, and from Leonard Avenue to just west of Spadina Avenue on both sides of Nassau Street from College Street to Dundas Street West, as a business improvement area under Municipal Code Chapter 19, Business Improvement Areas; and

WHEREAS City of Toronto Council has established a board of management for the Business Improvement Area, and appointed members to the Kensington Market Business Improvement Area Board of Management for a term expiring on November 30, 2010, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Kensington Market Business Improvement Area Board of Management;

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
  - A. The table in Schedule A, Boards of Management is amended by adding the new Kensington Market Board of Management as set out in Schedule A attached; and
  - B. Schedule A, Maps is amended by adding the attached maps of the Kensington Market Business Improvement Area.
2. A Board of Management for the Kensington Market Business Improvement Area is hereby established.

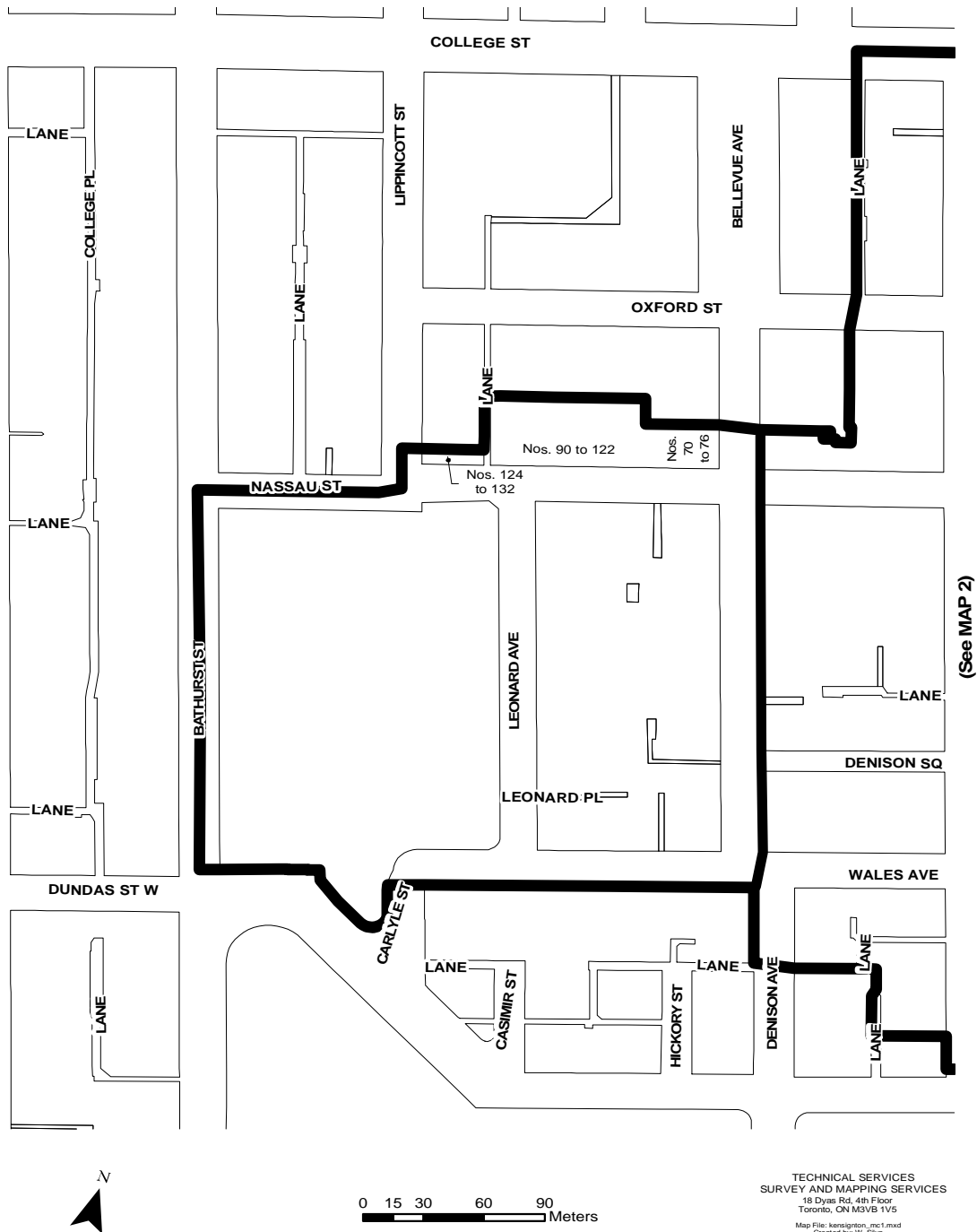

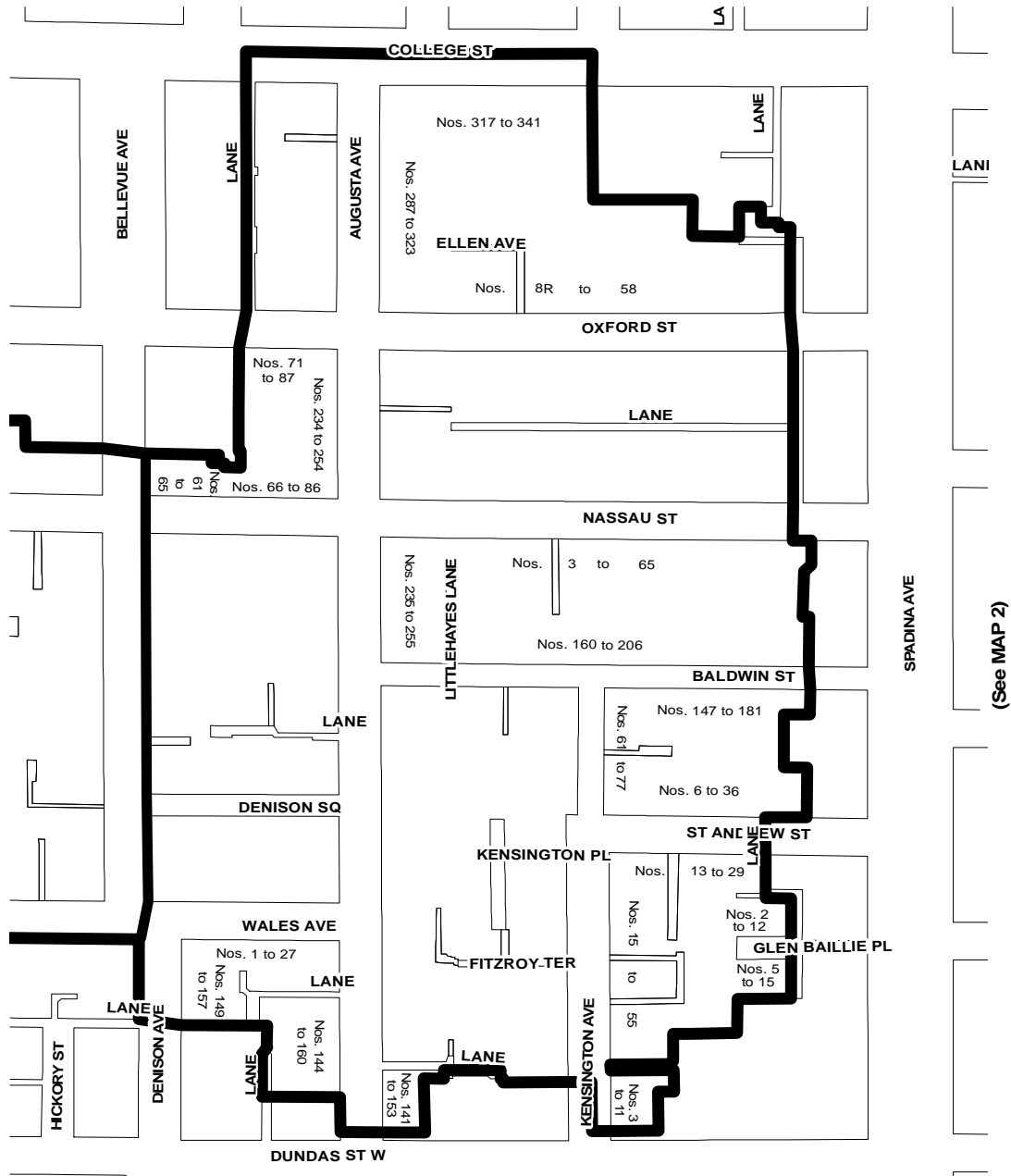
