BY-LAW No. 628-2010

To amend City of Toronto Municipal Code Chapter 545, Licensing, respecting amendments to the business licensing thresholds.

WHEREAS at its meeting of January 27, 28 and 29, 2004, City Council adopted the report from the Commissioner of Urban Development Services on the establishment of business licensing thresholds; and

WHEREAS By-law No. 117-2004 implementing the business licensing thresholds came into force July 1, 2004, and since then a number of operational challenges have been identified; and

WHEREAS By-law No. 116-2010, which amended the business licensing thresholds, came into effect on January 1, 2010; and

WHEREAS it is determined that further clarification of the business licensing thresholds is required to facilitate their application;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. City of Toronto Municipal Code Chapter 545, Licensing, is amended by:

deleting the following rows of Appendix K – Schedule A:

and replacing them with the following:

2. City of Toronto Municipal Code Chapter 545 Licensing, Appendix K - Schedule A is further amended by adding the following row immediately after the foregoing:

and sexual	causing bodily harm; Aggravated sexual assault; Assault		
assault	with a weapon or causing bodily harm; Aggravated		
offences	assault; Unlawfully causing bodily harm		

3. City of Toronto Municipal Code Chapter 545, Licensing, Appendix K is further amended by inserting the following definition immediately following the definition of "Conviction":

DEMERIT POINT — a unit applied for a by-law conviction in accordance with Schedule B of Appendix K of this Chapter, for purposes of administering the business licensing thresholds.

4. This by-law shall be deemed to have come into effect on January 1, 2010.
