**BY-LAW No. 691-2010**

**To amend By-law No. 30662 of the former City of North York, being a by-law  
"To prohibit parking of motor vehicles on all public highways within the jurisdiction of the  
Corporation of the City of North York", regarding Seeley Drive.**

The North York Community Council HEREBY ENACTS as follows:
