BY-LAW No. 718-2010

To amend further By-law No. 23503 of the former City of Scarborough, respecting the regulation of traffic on Wickson Trail.

The Scarborough Community Council HEREBY ENACTS as follows:

1. Schedule IX (No Stopping) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by striking out the following words and figures in Columns 1, 2, 3, and 4 of the said Schedule:

Wickson Trail	East	Lowry Square	38m north of Lowry Square	Anytime
Wickson Trail	West	Quantrell Trail	137m north of Quantrell Trail	7:00 a.m. to 6:00 p.m. Monday to Friday

Wickson Trail	North and East	Quantrell Trail and Lowry Square	42 metres further to the North and West	Anytime
Wickson Trail	North and East	42 metres North and West of Quantrell Trail and Lowry Square	112 metres further to the North and West	8:00 a.m. to 4:00 p.m. Monday to Friday except July, August and Public Holidays

(In Column 1) Highway	(In Column 2) Side	(In Column 3) From	To	(In Column 4) Times or Days	(In Column 5) Maximum Period Permit
Wickson Trail	South and West	61 metres North and West of Quantrell Trail and Lowry Square	131 metres further to the North and West	8:00 a.m. to 4:00 p.m. Monday to Friday	30 Minutes
