BY-LAW No. 741-2010

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Austin Terrace and Hilton Avenue.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule VIII (Prohibited Turns) in § 400-61, the following in alphabetical order by street name:
