CITY OF TORONTO

BY-LAW No. 801-2010

To authorize the narrowing of Roncesvalles Avenue between The Queensway/Queen Street West and Dundas Street West, by constructing built-out TTC-platforms and widening the sidewalks.

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. The narrowing of Roncesvalles Avenue by providing built-out TTC passenger loading platforms on either the east or the west side between The Queensway/Queen Street West and Dundas Street West at the following locations:
 - a. from Marion Street to a point 52.2 metres further south, from a width of 12.9 metres to a width varying between 9.8 metres and 11.5 metres;
 - b. from a point 8.4 metres north of Marion Street to a point 45.4 metres further north, from a width of 12.9 metres to a width varying between 9.8 metres and 11.5 metres;
 - c. from a point 6.5 metres north of Galley Avenue to a point 48.6 metres further north, from a width of 12.8 metres to a width varying between 6.6 metres and 9.8 metres;
 - d. from a point 6.5 metres south of Garden Avenue to a point 52.9 metres further south, from a width of 12.9 metres to a width varying between 6.6 metres and 9.8 metres;
 - e. from High Park Boulevard to a point 50 metres further south, from a width of 12.9 metres to a width varying between 6.6 metres and 10.1 metres;
 - f. from Fermanagh Avenue to a point 58.6 metres further south, from a width of 12.9 metres to a width varying between 6.6 metres and 11.7 metres;
 - g. from a point 15.3 metres north of Geoffrey Street to a point 53.1 metres further north, from a width of 12.9 metres to a width varying between 9.8 metres and 11.6 metres;
 - h. from widened north curb of Grenadier Road to a point 43 metres further north, from a width of 12.9 metres to a width varying between 7.6 metres and 11.4 metres;
 - i. from Howard Park Avenue to Marmaduke Street, from a width of 12.8 metres to a width varying between 6.6 and 11.7 metres;

- j. from a point 23.2 metres south of Howard Park Avenue to a point 55 metres further south, from a width of 12.8 metres to a width varying between 6.6 metres and 10.2 metres;
- k. from Boustead Avenue to a point 57.2 metres further south, from a width of 12.8 metres to a width varying between 6.6 metres and 10.1 metres;
- 1. from Dundas Street West to a point 100.9 metres further south, from a width of 12.8 metres to a width varying between 6.6 metres and 11.5 metres,

generally as shown on Drawing Nos. 421G-0036, 421G-0037, 421G-0038, 421G-0039, 421G-0040, 421G-0042, 421G-0043, dated May 2010, on file in the offices of Transportation Services, is authorized.

- 2. The narrowing of Roncesvalles Avenue by widening the sidewalk on either the east or the west side between The Queensway/Queen Street West and Dundas Street West at the following locations:
 - a. from Grafton Avenue to a point 26.1 metres further south, from a width of 17.3 metres to a width of 9.1 metres;
 - b. from a point 31 metres north of The Queensway to a point 31 metres further north, from a width of 17.3 metres to a width varying between 9.1 metres and 12.2 metres;
 - c. from a point 74 metres north of The Queensway to a point 79.3 metres further north, from a width of 17.3 metres to a width varying between 13.6 metres and 14.4 metres;
 - d. from Fern Avenue to a point 49.4 metres further north, from a width of 12.9 metres to a width of 10.7 metres;
 - e. from Wright Avenue to a point 10 metres further south, from a width of 12.9 metres to a width of 10.7 metres;
 - f. from Fermanagh Avenue to a point 30 metres further north, from a width of 12.8 metres to a width of 10.8 metres;
 - g. from Westminster Avenue to a point 22.7 metres further north, from a width of 12.9 metres to a width of 10.7 metres;
 - h. from Geoffrey Street to a point 15.2 metres further south, from a width of 12.9 metres to a width of 10.8 metres;
 - i. from Grenadier Road to a point 15.2 metres further north, from a width of 12.9 metres to a width of 7.6 metres;

- from Neepawa Avenue to a point 25.6 metres further south, from a width of j. 13 metres to a width of 10.7 metres;
- from Boustead Avenue to a point 49 metres further north, from a width of k. 12.8 metres to a width of 10.3 metres,

generally as shown on Drawing Nos. 421G-0036, 421G-0038, 421G-0039, 421G-0040, 421G-0041, 421G-0044, dated May 2010, on file in the offices of Transportation Services, is authorized.
