BY-LAW No. 813-2010

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Dufferin Street, Jameson Avenue, Springhurst Avenue and Tyndall Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

- A. By inserting in Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

- B. By inserting in Schedule VIII (Prohibited Turns) in § 400-61, the following in alphabetical order by street name:

- C. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

| Dufferin Street | West | Thorburn Avenue and a point 29 metres south of King Street West | 25 | Anytime from and including Fri. Aug. 20, 2010 to and including Mon. Sept. 6, 2010 |
