BY-LAW No. 877-2010

To amend further By-law No. 92-93, a by-law "To regulate traffic on roads in the Borough of East York", being a by-law of the former Borough of East York, regarding Strathmore Boulevard.

The Council the City of Toronto HEREBY ENACTS as follows:

1. Schedule IV (Stands for Taxicabs and Tour Buses) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by striking out the following words and figures where they appear opposite each other in Columns 1, 2, 3, 4 and 5 of the said Schedule:

(From Column 1 Road)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 # of Taxicabs)	(From Column 5 Hours)
Strathmore Blvd.	South	Between signs located 15 metres east Boulevard of the east curb of Woodbine Avenue and 29 metres east of the east curb of Woodbine Avenue	Two	Anytime

2. Schedule IV (Stands for Taxicabs and Tour Buses) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting in Columns 1, 2, 3, 4 and 5 of the said Schedule, in alphabetical order by road name, the following:

(In Column 1 Road)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 # of Taxicabs)	(In Column 5 Hours)
Strathmore Boulevard	South	A point 9 metres east of Woodbine Avenue and a point 44 metres further east	7	Anytime

3. Schedule VIII (No Parking) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by striking out the following words and figures where they appear opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(From Column 1 Road)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and Days)
Strathmore Boulevard	South	Woodbine Avenue and Cedarvale Avenue	Anytime

4. Schedule VIII (No Parking) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule, between the words "Stanhope Avenue" and "Strathmore Boulevard" where they appear in Column 1 of the said Schedule, the following:

(In Column 1 Road)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and Days)
Strathmore Boulevard	South	A point 81 metres east of Woodbine Avenue and Cedarvale Avenue	Anytime

5. Schedule IX (No Stopping) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by striking out the following words and figures where they appear opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(From Column 1 Road)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and Days)
Strathmore Boulevard	South	Woodbine Avenue and Cedarvale Avenue	Anytime

6. Schedule IX (No Stopping) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting in Columns 1, 2, 3 and 4 of the said Schedule, between the words "Secord Avenue" and "Sutherland Drive" where they appear in Column 1 of the said Schedule, the following:

(In Column 1 Road)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and Days)
Strathmore Boulevard	North	Woodbine Avenue and Cedarvale Avenue	Anytime
Strathmore Boulevard	South	A point 44 metres east of Woodbine Avenue and a point 81 metres further east	Anytime
