BY-LAW No. 931-2010

To amend further By-law No. 23503 of the former City of Scarborough, respecting the regulation of traffic on Bridgend Street and Port Union Road.

The Scarborough Community Council HEREBY ENACTS as follows:

1. Schedule IX (No Stopping) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:

(In Column 1) Highway	(In Column 2) Side	(In Column 3) From	To	(In Column 4) Times or Days
Port Union Road	All	A point northerly 15 metres north of the outside curb face of the roundabout	A point 10 metres south of the south limit of Bridgend Street	Anytime
Bridgend Street	Both	The westerly outside curb face of the roundabout	A point 15 metres further west	Anytime

2. Schedule XII (One Way Streets) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:

(In Column 1) Highway	(In Column 2) From	To	(In Column 3) Times or Days	(In Column 4) Direction
Port Union Road	A point 10 metres north of the north limit of Bridgend Street	A point 10 metres south of the south limit of Bridgend Street	Anytime	Traffic to proceed in a counter clockwise direction

3. Schedule XVIII (Through Streets) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by striking out the following words and figures in Columns 1 and 2 of the said Schedule:

(In Column 1) Highway	In Column 2) From	To
Port Union Road	South limit of Lawrence Avenue East	South limit of Port Union Road

4. Schedule XVIII (Through Streets) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by inserting the following words and figures in Columns 1 and 2 of the said Schedule:

(In Column 1) Highway	In Column 2) From	To
Port Union Road	Lawrence Avenue East	Bridgend Street

5. Schedule XIX (Compulsory Stops) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by striking out the following words and figures in Columns 1 and 2 of the said Schedule:

(In Column 1) Intersection	(In Column 2) Stop Street
Bridgend Street and Port Union Road	Bridgend Street

6. Schedule XX (Heavy Truck Prohibition) of By-law No. 23503 of the former City of Scarborough, as amended, is further amended by inserting the following words and figures in Columns 1, 2 and 3 of the said Schedule:

(In Column 1) Highway	(In Column 2) From	To	Column 3 Times of Days
Port Union Road	Lawrence Avenue East	South end of Port Union Road	Anytime
