BY-LAW No. 991-2010

To expropriate interests in multiple properties for the new Finch West Station and tunnel alignment in connection with the Toronto-York Spadina Subway Extension.

WHEREAS in accordance with the provisions of the *Expropriations Act*, applications have been submitted to City Council as approving authority for approval to expropriate the lands and interests in land hereinafter described; and

WHEREAS Notices of such Applications have been published and have been served on the registered owners of the said lands and interests in land; and

WHEREAS a notice in writing of a desire for a hearing with respect to the said proposed expropriation was not received from any owner of the said lands, and the time for giving such notice has expired; and

WHEREAS the Council of the City of Toronto, as approving authority, at the same meeting at which it is enacting this by-law, approved the said Application for Approval to Expropriate and gave leave to introduce and enact this by-law;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. The expropriation of the lands and interests in land set forth in sections 2, 3, and 4 is hereby approved by Council, as the expropriating authority, pursuant to sections 7, 8 and 9 of the *City of Toronto Act, 2006*, in connection with the Toronto-York Spadina Subway Extension Project.
- **2.** A fee simple interest and all other right, title and interests in the lands described in Schedule "A", is hereby expropriated and taken for the purpose of constructing elements of transit and/or other municipal systems.
- **3.** A limited interest in the lands described in Schedule "B", being a permanent easement, is hereby expropriated and taken for the support and safe operation of subsurface transit and/or other municipal systems, including rights to restrain alterations to such lands, changes in use, and storage of materials which may impact the load on the subsurface systems or otherwise impact their safe operation.
- 4. A limited interest in the lands described in Schedule "C", being a temporary easement for a limited time, is hereby expropriated and taken for construction purposes, including the right to pass over and occupy the lands with all personnel, materials and equipment for the periods specified in Schedule "C", to run from the date that construction is to commence on the lands.

- 5. Authority is hereby granted for the signing, sealing and registration in the proper Land Registry Office of the plans showing the lands and interests in land to be expropriated, including the payment of all expenses incidental thereto.
- 6. City staff are hereby authorized to serve on the former registered owners of the lands and interests in land described in sections 2, 3, and 4 hereof, the Notices of Expropriation (along with copies of Notices of Election as to a Date for Compensation) and the Notices of Possession as contemplated by the *Expropriations Act*.
- 7. The Mayor and the proper officers of the City are hereby authorized and directed to do all things necessary to give effect to this by-law, and the City Clerk and City Treasurer are hereby directed to execute all documents necessary in that behalf, and the said Treasurer is hereby authorized and directed to affix the corporate seal of the City to all such documents.
