CITY OF TORONTO

BY-LAW No. 1075-2010

To amend City of Toronto Municipal Code Chapter 441, Fees and Charges and City of Toronto Municipal Code Chapter 849, Water and Sewage Services and Utility Bill, to reflect the extension and continuation of the 2010 water and wastewater service rates and the 2010 water rebate for eligible low-income disabled persons and low-income seniors enacted by By-law No. 1206-2009.

WHEREAS section 259 of the *City of Toronto Act, 2006* provides that the City may pass by-laws imposing fees or charges on persons for services or activities provided or done by or on behalf of it; and

WHEREAS City Council has the authority to pass this by-law pursuant to subsections 8 (1) and (2) and section 259 of the *City of Toronto Act, 2006*; and

WHEREAS City Council at its meeting on November 30, December 1, 2, 4 and 7, 2009 enacted By-law No. 1206-2009 which, among other things, set the new water and wastewater rates to be charged to metered and flat rate consumers effective January 1, 2010, public notice having been given, and approved the 2010 water rebate for eligible low-income seniors and disabled persons; and

WHEREAS City Council has now approved the extension and continuation of the 2010 water and wastewater rates and the 2010 water rebate for eligible low-income seniors and disabled persons as set out in By-law No. 1206-2009, until such time that City Council adopts Toronto Water's 2011 Operating and Capital Budgets and any corresponding changes, which may be necessary, to the water and wastewater service rates and water rebate, public notice having been given; and

WHEREAS Chapter 441 of The City of Toronto Municipal Code is the codified consolidated user fee by-law for the City of Toronto ("Municipal Code Chapter 441"); and

WHEREAS Chapter 849 of The City of Toronto Municipal Code is the Water and Sewage Services and Utility Bill by-law for the City of Toronto ("Municipal Code Chapter 849");

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Paragraphs 1, 2 and 3 of By-law No. 1206-2009 are hereby extended and continued on and after January 1, 2011 until such time as Council of the City of Toronto adopts such other rates.
2. Paragraph 4 of By-law No. 1206-2009 is amended, effective January 1, 2011, by deleting "2010" and replacing it with "2011" in Section 849-14.5D, Chapter 849, Water and Sewage Services and Utility Bill, of the City of Toronto Municipal Code, and paragraph 4 of By-law No. 1206-2009, as so amended, is hereby extended and continued on and

after January 1, 2011 until such time as Council of the City of Toronto adopts such other water rebate rate.

- 3.** All other paragraphs of By-law No. 1206-2009 continue in full force and effect.
