CITY OF TORONTO

BY-LAW No. 1148-2010

To amend City of Toronto Municipal Code Chapter 227, Reserves and Reserve Funds to create new reserve funds and reserve fund accounts, to close certain reserves, reserve funds, and reserve funds accounts, and to amend the purpose of certain reserve funds and reserve fund accounts.

WHEREAS City Council has approved the creation of new reserve funds and reserve fund accounts, the closing of certain reserves, reserve funds, and reserve funds accounts, and new purposes of certain reserve funds and reserve fund accounts; and

WHEREAS City of Toronto Municipal Code Chapter 227, Reserves and Reserve Funds requires amendment to reflect these decisions;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. (1) The North York Arena reserve fund is hereby established for the purpose of providing a source of funding for the construction of a new twin-pad arena within the vicinity of the Don Mills Centre.
 - (2) The Edithvale Land Acquisition reserve fund is hereby established for the purpose of providing a source of funding for expanding Edithvale Park by the acquisition of additional land.
 - (3) The Animal Services Efficiency reserve fund account is hereby established for the purpose of funding debt charges arising from the South Regional Animal Centre.
 - (4) The purpose of the Public Health Efficiency reserve fund account is hereby changed to funding debt charges arising from the Toronto Community Health Information System.
 - (5) The purpose of the Tam Heather reserve fund is hereby changed to receiving and annual contribution up to \$30,000 from the Tam Heather Curling and Tennis Club (once any previous deficit is paid off) to be used to provide a source of funding for any capital maintenance to the facility.
 - (6) The purpose of the Exhibition Place Conference Centre Reserve Fund is hereby changed to providing a source of funding for any shortfalls in loan payments to the City from Exhibition place of the new conference centre or to support Exhibition place's operating shortfalls between 2010 and 2012, to a maximum of \$0.900 million.

- (7) The following reserves, reserve funds and reserve fund accounts be closed:
 - (a) All Borough Mortgage and Loan;
 - (b) Toronto Community Housing Corporation State of Good Repair;
 - (c) Community Heritage;
 - (d) Development Charges (2004) Library;
 - (e) Client Identification and Benefits System;
 - (f) Sony Centre Improvements; and
 - (g) Legal Vehicle.
- **2.** City of Toronto Municipal Code Chapter 227, Reserves and Reserve Funds is amended as follows:
 - (1) Schedule No. 1 Corporate Reserves be amended by:
 - (a) deleting the following reserve account:

- (b) deleting the Legal reserve account within the Vehicle and Equipment Replacement Group.

(b) amending the purpose of the Public Health Efficiency reserve fund account by deleting the words "Provides funding to fund debt charges arising from the Toronto Community Health Information System (formerly known as Community Nursing Customer Management System) and the South Regional Animal Centre" and substituting the words "Funding debt charges arising from the Toronto Community Health Information System".

(3) Schedule No. 8 – State of Good Repair Discretionary Reserve Fund be amended by deleting the following reserve fund account:

- (9) The purpose of the Tam Heather Reserve Fund in Schedule No. 14 State of Good Repair Obligatory Reserve Funds be amended by deleting the words "Provides funding to improve facility or to cover operation deficits of the Tam Heather Country Club" and substituting the words "Receiving an annual contribution up to \$30,000 from the Tam Heather Curling and Tennis Club (once any previous deficit is paid off) to be used to provide a source of funding for any capital maintenance to the facility."
- (10) The purpose of the Exhibition Place Conference Centre Reserve Fund in Schedule No. 15 Third Party Agreements Obligatory Reserve Funds be amended by deleting the words "Provides a source of funding for any shortfalls in loan payments to the City from Exhibition Place for the new conference centre" and substituting the words "Provides a source of funding for any shortfalls in loan payments to the City from Exhibition Place for the new conference centre or to support Exhibition Place's operating shortfalls between 2010 and 2012, to a maximum of \$0.900 million."
